stated that he was not elected as a faculty member and then moved into the director's powas already serving as directore where by the faculty of the College of Business and Technology to represent them.

Parliamentarian Deitz reminded senators that faculty have asked the Executive Committee questions regarding the eligibility of service on Faculty Senate, and while this may be a sen topic, the question is whether this proposal should go to the broader group of faculty to s want to decide for themselves who should serve on the Senate.

Dr. Rock stated that he has been a faculty member for 27 years amdthes Faculty Senate for 12, and there have never been more than a couple of chairs on the Senate at all during those years. He stated that sometimes department chairs have chaired the Faculty and he has had nothing but appreciation for what they have brought to the table. He believe are able to bring a viewpoint and information that most faculty simply do not have, and he is important that they still have access to this body. He noted that chairs will never make majority of the Faculty Senate and believes that it is up to the electorate to decide who be represents their interests to the darge and college appointments.

Chairperson Pynes noted that there are many uncontested blacksidhs; current body is too big and would be interested to see how often elections are uncontested. He noted that the most recent election the deadline had to be extended for three colleges.
